Petition to reconstruct and maintain an existing drainage system.

To the Board of County Commissioners,

Allen County, Ohio

The undersigned hereby petitions your honorable body to reconstruct and maintain an existing drainage system on the course hereinafter set forth.

The construction of the improvement is necessary, will benefit the petitioner and will be conducive to the public welfare. The Project shall be identified as the **Dutch Hollow Road Drainage Improvement Project #1344.** 

## The following is the proposed course and termini of the project to wit:

Commencing on the west side of Dutch Hollow Road, approximately 140 feet north of the centerline of River Trail, that point being near the SE corner of the NE 1/4, of the NE 1/4 of the SE 1/4 of Section 18, American Township, Allen County, Ohio. Thence continuing northwesterly downstream approximately 2,675 feet to its confluence with the Ottawa River, that point being near the NW corner of the E 1/2 of the NW 1/4 of the SE 1/4 of Section 18, American Township, Allen County, Ohio.

All costs of field investigation, surveying, engineering, construction, and future maintenance will be assessed to the benefiting parcels of land, except as ordered under Section 6131.31 of the Revised Code.

## The following is the nature of the work petitioned for:

Replace and/or repair the existing drainage system with a new drainage system that is adequate in size to alleviate the drainage and maintenance problems in the watershed, as deemed necessary by the Allen County Engineer.

A list of the names and addresses, where known, of all the owners of the land which the petitioner or the County Engineer claims will be benefited or damaged by the construction of the proposed improvement will be supplied by the County Engineer's Office.
