REINFORCED CONCRETE BOX CULVERT**

The following legal notice is to receive bids to supply, deliver, and erect 72 feet of 16'x7' reinforced concrete box culvert as specified in Ohio Department of Transportation Construction and Material Specification 611 dated January 1, 2023. Erection of the culvert shall include supplying a crane, setting of the boxes as shown in the plans, supplying and pulling the boxes tight using a hydraulic pipe puller, supplying and installing a resilient and flexible gasket joint as shown on the plans, and supplying and installing joint wrap as shown on the plans. Bedding and backfilling work are to be supplied and performed by Allen County Forces and are NOT a part of this agreement. Prices to be indicated as delivered to and erected at the job site.

All contractors and subcontractors involved with the project will, to the extent practicable use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

Each bidder is required to furnish with its proposal, a Bid Guarantee and Contract Bond in accordance with Sections 153.54 and 153.571 of the Ohio Revised Code. Bid security furnished in Bond form shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein.

No bidder shall be permitted to withdraw its bid for a period of thirty (30) days after the time of bid opening.

The Board of Allen County Commissioners, Allen County, Ohio reserves the right to reject any or all bids submitted or to waive any irregularities pursuant to Section 9.31 of the Revised Code.
